"The European Pillar of Social Rights: Five years on"

The European Pillar of Social Rights (EPSR), proclaimed in Gothenburg in November 2017, sets out 20 principles and rights essential for fair and well-functioning labour markets and social protection systems. The EPSR Action Plan, adopted in May 2021, proposes headline targets for the EU to reach by 2030. However, five eventful years after the Pillar was proclaimed and in the context of Russia's war in Ukraine and the cost-of-living crisis, where does the EU stand on implementing the EPSR and meeting the three Action Plan's targets?
